4) Financial position

To note that the Trust normally allocates interest and preserves the capital fund. In general, this means approximately $\pounds 25k$ has been available in recent years. However, the previous two years have seen allocations less than the interest earned and so there is flexibility for the Trustee to award a higher sum if that is the preference.

In 2020/21 the Trust allocated £15,710 (after some grants were not taken up as a result of covid) and interest of £27,415 was earned. In the previous year there was interest of £27,301 and grants made of £17,590.
