There were three members of the public and one member of the press in attendance.

Prior to the meeting, prayers were led by the Revd Alan Crawley of the Parish of Badshot Lea and hale.

C109/22 Apologies

Apologies were received from Cllr Cockburn, Dickson and Fraser.

C110/22 Disclosures of Interest

Cllr Merryweather and Cllr Mirylees declared a disclosable interest as portflio holders for Waverley Borough Council in relation to the Farnham Museum discussion.

CIII/22 Minutes

The Minutes of the meeting held on 16th March were agreed.

C112/22 Town Mayor's Announcements

The Mayor welcomed everyone to the last meeting of the 2019-2023 administration.

He congratulated Millie Sobey Farnham's Events Apprentice who had just won Apprentice of the Year in the Great British Business and Community Awards. This was an amazing achievement beating over 70 other nominations. He added his congratulations to Oliver Cluskey who had been her mentor, and other staff colleagues who had supported her.

C113/22 Questions and Statements by the Public

Mr Graham White made observations on the ridiculous traffic situation in town as a result of the closure of West Street. He described a short journey he had just taken which had been an additional journey time of I hour 15 minutes because of traffic congestion. In his view, the water works should be suspended immediately until there was a proper plan to manage the traffic implications.

Cllr Beaman thanked Mr White and advised him that he had lost patence with South East Water. He had asked them three critical questions – whether they appreciated and acknowledged the significant economic consequences of their work; whether they would be paying compensation; and what was to stop them doing one lane working with traffic lights. Cllr Beaman was awaiting a response.

C114/22 Questions by Members

There were no Questions by members.

C115/22 Working Group Notes

Cllr Evans introduced the Notes of the Strategy & Finance Working Group held on 18th April 2023 at Appendix B to the Agenda advising that the end of Year Finance papers would be taken under a separate agenda item.

i) Cllr Evans reported that the Working Group had reviewed the list of Direct Debits and Standing Orders that would be applicable in the year ahead and there had been some grant applications considered.

It was RESOLVED nem con that

- 1) The Standing Orders and Direct Debits for 2023/24 be noted;
- 2) The Farnham Ukrainian Weekend Club be supported with funds for equipment and materials from donations received;
- 3) The Council's policy of supporting locally-based charities be re-affirmed but that an opportunity for a fundraising/profile raising event for the Air Ambulance Charity be encouraged.
- ii) The Working Group recommended that a new door into the kitchen at Wrecclesham Community Centre to improve safeguarding be agreed.

It was RESOLVED nem con that Landlord's Consent to the request for a new internal door to the kitchen at Wrecclesham Community Centre be approved.

iii) Cllr Evans provided an update on contracts and assets matters and Council noted that the Hale Chapels Garden was almost complete. Council considered the delegated decision to finish the scheme on a recommendation from the Cemeteries & Appeals Working Group members with some mature trees and shrubs. The project was one for which the Council can be rightly proud, and an opening was provisionally scheduled for June.

Council also received details of a proposal to add another polytunnel on the allotments (reserved cemetery land) adjacent to the Nursery pending a further report on reconfiguring the Nursery.

Council noted that a tender had been undertaken for the Council's Insurances with Zurich, BHIB and Gallaghers being invited to bid. A three year deal with the potential to extend was being recommended.

It was RESOLVED nem con that:

- 1) The progress on the Hale Chapels' Garden be welcomed;
- 2) the decision to vary the planting scheme with additional shrubs and trees at an additional cost of up to £5,000 be endorsed.
- 3) a new polytunnel and equipment be purchased with the estimated cost of £10,000 to be met from the insurance earmarked reserve.
- 4) A new three year agreement (with the potential to extend this to five years) for the Council's Insurances be entered into with Zurich up to a cost of £12,500.
- iv) Cllr Evans advised that the Terms of Reference for Working Groups and Panels at Annex I had been reviewed and were recommended for adoption.

It was RESOLVED nem con that the Working Group Terms of Reference be approved.

v) Council received an update from the Infrastructure Planning Group, the Conservation Areas Task Group (CATG), and the Riverside Sculpture Task Group. Folowing an proposal by Cllr Beaman to strengthen the recommendation, seconded by Cllr Hesse, Council expressed great concern that the Farnham Design Statement submitted to Waverley some 15 months ago was still not agreed despite the Council's suggested changes being included as requested. It was agreed that Waverley should be advised of the extreme concern and requested to deal with the matter without further delay. Council noted the progress of the Yards of Farnham project and the repair of the Farnham Flame. Council also received details of a complaint by residents of Hawthorn Lodge about the new public art by Longbridge and the Riverside, funded by Section 106 funding from the UCA development. It was noted the residents had made a complaint to Planning Enforcement whose consideration was awaited. Councillors expressed surprise that the residents were seemingly unaware of the project which had a lot of public engagement and felt it important that the claim about this being public money should be corrected.

It was RESOLVED nem con that Farnham Town Council express its deep concern and further request that Waverley Borough Council adopt the Farnham Design Statement as a minimum as a Material Planning Consideration pending work on the Local Plan and Neighbourhood Plan.

vi) Cllr Beaman gave an update of the work of the Farnham Infrastructure Programme, and Councillors acknowledge the detailed response he had sent following the last council. There was a debate on the ongoing position of the planters in Downing Street which were considered by some to be adding to the congestion caused by the closure of West Street.

Some Councillors felt the gridlock would have been just the same if there had been no planters, and the planters were still much better for pedestrians (noting the CCTV showed how much people stepped off the pavement) and had stopped at least two crashes into shops because they had taken the impact. Cllr MacLeod advised this was a matter for Surrey County Council to deal with particularly if there was an issue for emergency vehicles. Cllr Hesse thanked Cllr MacLeod for taking this up with Surrey and asked him to urge Surrey to get improvements on the ground sooner than later.

vii) Cllr Evans advised that Mr Michael Stephens had been appointed as Farnham Town Crier.

Cllr Mirylees gave an update on the work of Tourism and Events and the planned programme for Coronation weekend. She also reminded Councillors of the Walking Festival programme and other events including Music In the Meadow and the sustainability Festival.

Council noted the launch of In Bloom and that the Green Flag judging would be taking place in May for Gostrey Meadow, and the West Street and Badshot Lea Cemeteries.

The Mayor proposed a vote of thanks (to a round of applause) for all staff, councillors and volunteers who had contributed to the success of the town council's activities.

C116/22 Approval of End of Year Accounts 2022-23

Cllr Evans introduced the report on the end of year accounts at Appendix C. She advised that there had been a long and thorough discussion on the detail at Strategy & Finance which was set out in the report.

Cllr Evans said that 2022-23 was a fairly unique year given the capital projects that took place (completion of the refurbishment of the Central Car Park Public Conveniences, the completion of the restoration of the listed West Street cemetery gates, the commissioning of the public art work at Longbridge with Section 106 funding from the UCA developments, and the undertaking of the conversion of the Hale Cemetery Chapels into a Community Garden. The celebration of the Platinum Jubilee of Her Majesty Queen Elizabeth II, followed by her death and the proclamation of His Majesty King Charles III, and the visit of His Royal Highness Prince Edward, gave an exceptional Royal flavour to civic and community events. In addition, the international situation with the War in Ukraine and post Brexit issues leading to rising energy prices, high inflation and supply-chain issues has led to significant cost uncertainties in managing the Council finances.

Despite this, Council made a prudent approach to the 2023-24 precept bearing in mind the pressures on the community and made a small increase it its share of the Council Tax which is expected to again be below the sector average for the IIth successive year and the financial outcome has been positive.

Cllr Evans reported that the overall income position was £1,914,697 (against a prudent budget of £1,474,800) whilst expenditure was £1,816,684 (against a budget of £1,474,800). This had resulted in a surplus of income over expenditure of £98,013. However, this was not a straight surplus with some £290,322 required to be transferred to earmarked reserves

(as budgeted or ringfenced) and there was £191,850 or reserves designated for capital projects undertaken during the year used as expected.

Council reviewed the following documents

The 2022/23 Income and Expenditure Outturn at Appendix D; the Bank Reconciliation and Balances at 31st March at Appendix E; the final Internal Auditor's Report for the Year Ended 31 March 2023 at Appendix F; the Report and Financial Statements for 2022/23 and earmarked reserves at 31st March 2023 at Appendix G; the variances list between 2021/22 and 2022/23 Annual Returns at Appendix H; the Annual Governance Statement (Section 1 of Annual Governance and Accountability Return at Appendix I.

Council welcomed the report of the Independent Internal Auditor and agreed all the points within it. The movement in earmarked reserves following the capital projects undertaken during the year and new requirements (including some provision for the update of the Neighbourhood Plan, and provision for improving the visitor experience at Farnham Museum following the improvements being carried out.) were agreed.

Council agreed to approve the Annual Governance and Accountability Return for the Year Ended 31st March 2023 for signature and submission for External Audit, and thanked the Town Clerk, the Bookkeeper and Accountant for the work done.

It was RESOLVED nem con that the:

- I) report at Appendix B be adopted;
- 2) 2022-23 Outturn at the end of an exceptional year be welcomed;
- 3) the Annual Governance Statement (Section 1 of the Annual Governance and Accountability Return, page 4) be approved;
- 4) Internal Auditor's report be welcomed and the recommendations agreed;
- 5) updated Asset Register be approved;
- 6) Report and Financial Statements for 2022-23 be adopted for signature;
- 7) variances list for the Annual Return be agreed;
- 8) General and Earmarked Reserves be agreed with the addition of the Pledge for £10,000 for Farnham Museum to improve the visitor experience to be met from the CIL Earmarked Reserve;
- 9) Annual Governance and Accountability Return and associated papers be approved for signature and submission to the External Auditor.
- 10) Period for the Exercise of Public Rights be from 12th June to 21st July.

C117/22 Planning and Licensing Applications

Council received the minutes of the Planning & Licensing Consultative Group meetings held on 20th March, 3rd and 17th April 2023 at Appendices J, K, and L noting thatthey had been busy meetings. It was hoped the new Council would pick up where the retiring Council had left off to protect Farnham in the best way it could. Applications in the meantime would be forwarded to Waverley under the scheme of delegation in cusultation with councillors who were re-elected.

The Mayor thanked (to applause) Jenny de Quervain for her diligent work in support of the Planning & Licensing Working group.

C118/22 Actions taken under the Scheme of Delegation

There were no additional actions to report.

C119/22 Reports from Other Councils

- I) Cllr Martin reported that a scoping scheme to upgrade Bourne Crossroads was the only scheme in Waverley to get support. Hopefully a signal controlled crossing would be installed within a year.
- 2) Cllr Martin reported that the proposed closure of Park Row to repair damage to the Alms Houses caused by an HGV had been deferred to avoid further problems with the West Street closure extended. Coullors hoped the Alms Houses would be able to seek compensation from South East Water for the inconvenience. Cllr Martin advised that a meeting was being organised with South East Water to discuss comepnsation for businesses affected by the closure.

C120/22 Reports from Outside Bodies

Cllr Beaman reported of the closure of Aldershot Bus Station in May which came with some timetable revisions. There was an improved bus service to Sandy Hill which was to be welcomed and the introduction of new Sunday bus services.

C121/22 Date of Next Meeting

The Mayor announced that the initial dates in the new Council year were as follows:

C122/22 Concluding Comments from the Mayor

The Mayor closed the meeting by thanking everyone for their contribution over the past four years, Councillors, staff and Farnham's wonderful volunteers. He paid particular thanks to councillors who had decided to stand down from Farnham Town Council at this election, many from significant service to our local community including Cllrs Attfield, Dunsmore, Evans, Fraser, MacLeod, Neale, and Wicks.

No one knew what the electorate would decide, but he wished all candidate every success in the forthcomming election.

Prior to the meeting, prayers were led by Revd Dr Michael Hopkins of the Spire Church.

C1/23 Election of the Town Mayor 2023/24

The Mayor handed the chair to the retiring Deputy Mayor Michaela Wicks for this item.

Cllr Merryweather proposed and Cllr Murray seconded Cllr Alan Earwaker to continue as Mayor for 2023-24.

In proposing Cllr Merryweather said he was delighted to speak in favour of Cllr Earwaker. The Mayor had two distinct roles as ambassador upholding the character of the town and supporting Council in carrying out its role. In the previous two years, supported wonderfully by Claire as Mayoress, Cllr Earwaker had represented Farnham Town Council superbly; supporting his charities and excelling in chairing meetings fairly and effectively. Council is incredibly lucky to have such an able Mayor and to his credit Council wishes to have him continue for 2023-24. In seconding the proposal, Cllr Murray echoed what had been said. Having seen Cllr Earwaker in action he was an incredible Mayor and a sage-like figure with helpful advice for all councillors.

There being no other nominations, it was **RESOLVED** *nem con* that Cllr Alan Earwaker be Mayor for 2023-24.

C2/23 Declaration of Acceptance of Office of Mayor

Having made his declaration of acceptance of office, Cllr Earwaker said he was deeply honoured and grateful to have been elected as the Mayor of Farnham for a third year and expressed his sincere gratitude for Council's trust and support. It was a great privilege to be able to serve Farnham's wonderful community for another year and to work with all councillors at the start of the new administration.

The focus following the pandemic was "working together with the community, reviving Farnham". Strong foundations had been built, but there was more to do. The Mayor had been pleased to support his two charities, Farnham Assist and the Waverley Abbey Trust and had presented them both with a cheque for £2,500 towards their excellent work.

Cllr Earwaker said that as a theme for his new Mayoral year, he would focus on young people and how they can be better connected with each other and the Council. Farnham's youth is the future of the town, and he would offer what assistance he could to organisations across Farnham who support young people to ensure that they have improved support and opportunities to thrive. T

The Mayor looked forward to working with every one to make Farnham an even better place to live, work, and raise a family.

The Mayor presented the badge of office of Mayoress to his daughter, Mrs Alison Watts and resumed chairing the meeting.

C5/23 Minutes

The Minutes were deferred to the first business meeting of Council on 25th May.

C6/23 Town Mayor's Announcements

The Mayor began his announcements by congratulating all councillors on their election and commiserating with long-serving councillor Carole Cockburn who had not been re-elected. He announced the sad news of former Mayor Victor Duckett who had died and whose funeral was on 23rd May, and that former Mayor and Leader Pat Evans was in hospital having broken her hip. He would pass on the good wishes of Council for a speedy recovery.

The Mayor was delighted to conclude with news that the Farnham Youth Choir had won a Gold Medal in the International Choirs Competition held in Hull the previous weekend.

C7/23 Presentation of Councillor badges to new Councillors

The Mayor presented all new councillors with a Farnham badge of office of councillor.

C8/23 Presentation of Past Mayoress' Badge

The Mayor presented a past Mayoress' Badge and a bunch of flowers to Mrs Claire Earwaker Dos Reis for her support as Mayoress over the past two years.

The Mayor also presented a bunch of flowers to the outgoing Deputy Mayor, Michaela Wicks, for her assistance between 2021-2023.

C9/23 Election of Deputy Mayor

Cllr George Hesse proposed, seconded by Cllr Kika Mirylees, that Cllr Brodie Mauluka be Deputy Mayor for 2023-24. Cllr Hesse said that he had known Cllr Mauluka for seven years and had always enjoyed the music nights he put on at the Plough. Before coming to Farnham, he was working in Hampshire Youth Service and had a great passion for helping young people. He had no hesitation in commending him as Deputy Mayor. Cllr Mirylees agreed and said Cllr Mauluka would be a great asset to the Mayor and the Council.

There being no other nominations, it was **RESOLVED** *nem con* that Cllr Brodie Mauluka be Deputy Mayor for 2023-24.

C10/23 **Declaration of Acceptance of Office of Deputy Mayor**

After making his declaration of office and receiving his badge of office, Cllr Mauluka thanked Council for welcoming him so warmly and for giving him the honour and opportunity to be Deputy Mayor. He was looking forward to supporting the Mayor in carrying out his duties and serving the people of Farnham. He said it was a little daunting, but he was sure it would also be a very exciting year ahead.

The Mayor presented Mrs Caroline Mauluka with the badge of office of Mayoress.

C11/23 Appointment of Leader or Spokesperson of the Council

Cllr Ward proposed, seconded by Cllr Laughton, the continuation of a Joint Leader for the Year ahead with Cllr Graham White as Leader of the Council and Lead Member of Strategy & Resources and Cllr David Beaman as the lead for the Farnham Infrastructure Programme.

He explained the background to the importance of having a spokesperson who held a position of responsibility and as such the role of Leader avoided having a fallback situation

with a 'spokesperson' who, in many organisations is there because someone did not wish to face the public.

With the arrival of the Farnham Infrastructure Programme (FIP) and the amount of money to be invested in the town the job of Leader had become more than was appropriate for one person. Cllr Graham White had a strong business background and was an ideal leader with common sense, drive and the common touch. Cllr Beaman was an experienced councillor and had carried the FIP burden with ease in the past year and Cllr Ward was pleased he had agreed to take it on for another year.

It was RESOLVED nem con that Cllr Graham White be Joint Leader of the Council and Lead Member of Strategy & Resources Working Group and Cllr David Beaman be the Joint Leader and Lead for the Farnham Infrastructure Programme.

C12/23 Adoption of the General Power of Competence

Council considered the report at Appendix C, noting the requirement to readopt the General Power of Competence following the recent election. The Mayor confirmed that Farnham Town Council met the eligibility criteria as i) all councillors held office as a result of being declared elected (as opposed to being appointed or co-opted); ii) the Town Clerk was suitably qualified (holding the Certificate in Local Council Administration -CILCA) and iii) the Town Clerk had completed the relevant training in the exercise of the power.

It was RESOLVED *nem con* that Farnham Town Council confirms that it is eligible to use the General Power of Competence and readopts the General Power of Competence as a power of first resort.

C13/23 Appointment of Town Council's representative on the Farnham Infrastructure Board.

The Mayor advised that Council had appointed Cllr Beaman to lead on the Farnham Infrastructure Programme in the year ahead. It was **RESOLVED** *nem con* that Cllr Beaman would become the Town Council representative on the Farnham Infrastructure Programme Board, along with the Town Clerk.

Election of Working Groups 2023/24

- I Councillors have identified preferences for the Working Groups for 2023/24 in accordance with Standing Order 15. These are attached at Annex I, in order of preference for each Working Group as indicated by each councillor.
- 2 Some councillors expressed a preference for only the Working Groups for which they were interested whilst others have given a priority listing for all the Working Groups. This does not mean they are expected to serve on every Working Group and may wish not to take up a provisional allocation as the workload would be high.
- 3 Standing Order 15.1 f states that the overall membership of the Working Groups will reflect as closely as possible the political make-up of the Council with the intention that as broad a range of councillors as possible is represented. By convention, the Mayor is not appointed to Working Groups and can attend any Group ex-officio.
- There are three Working Groups plus two Standing Task Groups (HR Panel and Services to Farnham Awards) and the Planning and Licensing Consultative Group. Standing Order 15 f suggests (not mandatory) how places are to be allocated to ensure that those who are not members of the majority group are fairly represented. As such, with currently 2 out of 16 councillors, those who are not part of the majority group should have as a priority [at least] 12.5% of the available places or two places between the three Working Groups and representation on the Panels and Task Groups where possible. In practice, the Council has normally chosen councillors willing to serve rather than managing places proportionately. If a Task Group has more councillors wishing to serve than places available one place will be prioritised for a councillor not part of the majority group.
- 5 Councillors are invited to opt for or nominate for the remaining places, or withdraw if this is appropriate where there are more places than candidates. If there are more candidates than places available an election will take place for the vacant places only.
- 6 If a councillor wishes to fill a vacancy, this will still be considered by Council so that any further late additions may also be considered. In determining vacancies, the intention is usually to avoid overloading individual councillors with too many groups, and allow for as many councillors as possible to be part of Task Groups or Working Groups.

Working Groups

7 As a result of the preference exercise, thirteen councillors expressed an interest in the Strategy & Resources Working Group, ten of whom 10 (Cllrs Beaman, Brown, Fairclough, Hesse, Laughton, Martin, Merryweather, Murray, Ward and White) put the Working Group as a first

preference. It is proposed that four of the five majority group councillors should be appointed and one of the two non-majority group be appointed. Council agreed that Cllr White will be the Lead Member for Strategy & Resources. It has been agreed that Cllr Brown will be the non-majority Group representative. As a reminder, Lead Members of the Environment & Community Working Groups are also Members of Strategy & Resources ex officio if not previously appointed. There will be an election to appoint three of the remaining first choice preferences.

- 8 In relation to the remaining Working Groups the following expressions of interest were received.
 - Community Working Group Nine preferences for five places four of whom made it their first preference and would be deemed elected (Cllrs Dickson, Jackman, Mauluka, and Mirylees with one of the three second preferences being selected from either Cllr Laughton, Martin or Woodhouse.
 - Environment Working Group There are eight preferences for five places. There is one first preference (Cllr Woodhouse) and five second preferences (Cllrs Brown, Dickson, Hesse, Jackman and Merryweather, one of which would be prioritised for a councillor from the minority group.
 - Planning & Licensing Consultative Group Seven councillors have expressed a preference for the eight places available. These are Cllr Murray (Bourne), Cllr Hesse (Castle), Cllr White (North West), Cllr Mauluka (Shortheath & Firgrove), Cllr Brown (Weybourne) and Cllr Laughton (Weybourne) and Cllr Woodhouse (Wrecclesham & Rowledge).. This means there are vacancies for Badshot Lea and Moor Park, and Hale & Heath End). The aim is, if possible, to have one councillor from each ward. Council may wish to appoint the seven councillors who have expressed a preference to be on the Consultative Group or elect one councillor per ward. All councillors are requested to review applications in their own wards and feed in to the fortnightly meetings.
 - **HR Panel** There are six preferences for six places. These are Cllr Brown, Jackman Mirylees, Ward, White, Woodhouse. (The HR Panel has previously requested that the panel (as far as possible) retains consistency during the life of the Council. The six councillors would be deemed elected.
 - Services to Farnham Awards Panel. The Panel meets to agree awards and to review nominations to external Trusts (such as the Dempster Trust, the Isabella Schroder Trust, and the Farnham Parochial Charity) as and when vacancies occur for which the Council is to make appointments. The Mayor and Deputy Mayor are ex-officio members and there are places for two (normally) other councillors. Colin Channon is on the panel representing the Tindle News Group as the Awards were the Inspiration of Sir Ray Tindle CBE DL. There is also provision for an additional independent representative.
 - Preferences have been received from Cllrs Brown, Jackman, Laughton, Mirylees and Woodhouse. It is proposed that two councillors are appointed.
- Following the election to the Working Groups and Panels it is proposed that Council is adjourned briefly so that each Working Group can elect its Lead Member to confirm the composition of the Strategy & Resources Working Group.

Task Groups

All Task Groups cease at the end of a Council year. Council needs to confirm if the Task Groups are to be reconvened. The HR Panel (technically a Task Group of both Strategy and Resources and Council) and the Services to Farnham Awards Panel are Standing Panels and are expected to continue whilst the remaining Task Groups need a formal resolution to be re-established. There are a number of new Task Groups/advisory Groups proposed to

formalise activity that is already undertaken or to fit with the new Working Group structure. Where it is decided that a Task Group or Advisory Group is not needed, or there are insufficient members, the work of the group will be undertaken by its 'parent' Working Group.

It is recommended that

- 1) the following be re-established as there is work to be done:
 - Assets Task Group
 - Cemeteries Appeals Panel
 - Community Infrastructure Levy/Section 106 Task Group
 - Conservation Areas Advisory Group (with external involvement)
 - Farnham in Bloom Community Group (with external involvement)
 - Infrastructure Planning Task Group
 - Young People Task Group (with external involvement)
 - Allotment Group (with allotment representatives).
- 2) the following be created/formalised to fit with the Council's priorities
 - Craft Town Advisory Group (with external involvement)
 - Business Advisory Group (with external involvement)
 - Literary Festival Advisory Group (with external involvement)
 - Well-being Task Group (with external involvement)
- Subject to Council's decision on Task Groups, the appointment to Task Groups will need to be agreed. In accordance with Standing Order 15 (f) membership of task groups does not need to conform to the political make-up of the council although in practice there should always be a space for the non-majority group on each Task Group. Other people outside the Council can be appointed to or co-opted onto Task Groups.
- 12 Subject to the decision on paragraph 10:
 - The Infrastructure Planning Group has seven councillors offering to fill five places.
 Four first preferences (Cllr Beaman, Hesse, Martin, and Merryweather) with Cllr
 Laughton and Cllr Murray making second preferences making up the places. It is
 proposed either Cllr Laughton or Murray are elected for the fifth place with third
 preferences (Cllrs Dickson and Woodhouse) being discounted.
 - The Assets Task Group has eight councillors for five places. There are three first
 preferences and two second preferences meaning Cllrs Brown, Dickson, Fairclough,
 White & Woodhouse would be deemed elected and Cllrs Laughton, Martin and
 Merryweather discounted.
 - The CIL/Section 106 Task Group has eight preferences for the five places. With five second preferences, the following would be deemed elected (Cllrs Dickson, Fairclough, Hesse, Martin and White) with Cllrs Laughton, Merryweather and Woodhouse discounted.
 - Conservation Areas Advisory Group has three councillors expressing a preference (Cllrs Laughton, Merryweather and Woodhouse). The expectation is that councillors who have a conservation area within their ward may wish to be part of this group. The Group is supplemented by external organisations. Ideally there will be a minimum of three councillors so all councillors are deemed elected, with scope for others if appropriate.

- Young People Task Group. Seven councillors for five places. Cllrs Brown, Jackman and Mauluka put this as their first preference with Cllrs Laughton, White, and Merryweather also including it as a top six preference. It is proposed that Cllrs Brown, Jackman, and Mauluka, are deemed appointed with two appointed from Cllrs Laughton, Merryweather and White. Cllr Woodhouse would be discounted.
- Literary Festival Advisory Group. Cllrs Jackman and Merryweather and Mirylees included this in their priority preferences and as such are deemed appointed with Cllrs Laughton discounted
- Business Advisory Group. Cllrs Brown, Laughton, Martin, Merryweather, Murray
 and Woodhouse expressed this as a priority preference. Five of the six priority
 preferences should be chosen with Cllr Jackman discounted.
- **Craft Advisory Group**. Cllrs Hesse, Woodhouse, Jackman, Laughton, Merryweather and Mirylees expressed an interest. Three should be appointed.
- Wellbeing Task Group. Only Cllr Jackman gave this a top 5 priority and it is proposed that the work of the Task Group be covered by the Community Working Group initially and that the Task Group be considered for appointment later in the year.
- Allotment Liaison Group. Cllrs Mauluka, Jackman and Woodhouse gave this a top three preference. It is proposed that a Lead Councillor and reserve councillor be appointed to attend.
- Farnham in Bloom Community Group. Cllrs Hesse, Jackman and Mauluka expressed interest in joining the Farnham in Bloom Community Group with first or second preference. It is proposed all three be appointed.

Annex I has the proposals for each Task Group for consideration by Council.

Recommendation

It is recommended that:

- I) the candidates for the Strategy & Resources, Community and Environment Working Groups be appointed as set out in Annex I along with any additional councillors to fill the remaining vacancies as set out in paragraph 7-9 above:
- 2) Council determine if the councillors willing to be on the Planning and Licensing Consultative Group be appointed or whether one councillor per ward is appointed;
- 3) the Working Groups elect their Lead Members (in order to do which the meeting be adjourned briefly) in order to confirm the complement of Strategy and Resources Working Group Members; and
- 4) Council determines which Task Groups and Advisory Groups be appointed and the suggested size and membership of each Task Group or Advisory Group as set out in Annex I.


