From Councillor George Hesse to the Co-Leaders/Town Clerk.

I would like to ask the following Member's question concerning vehicles continuing to speed through the Town Centre's 20mph Zone and the risk to the safety of pedestrians.

This issue may have come to Members' attention even if you don't live in the town. Speeding and extremely reckless driving has been witnessed by Members who live in or close to the town centre. As one of Castle Ward's Councillors I have had a number of requests from residents asking for safe crossings and speed calming measures in several locations.

At the December Farnham Town Council meeting, it was agreed to press for a crossing across Longbridge between Gostrey Meadow and the Maltings, funded by the savings of changes to the Farnham Infrastructure Programme (FIP) town centre improvements proposed by Farnham Town Council, as this crossing was always considered part of the (FIP) Scheme. However, this has not yet been accepted by officers of Surrey County Council.

Accordingly I am asking the question,

"Would colleagues support making an official request to Surrey County Council for the installation of the following crossings and a safety improvement:-

- I. Reinforcing the need for the previously approved Longbridge Crossing which could be a Belisha Beacon with a speed calming raised table;
- 2. A new shrouded Belisha Beacon crossing on West Street between Mead Lane and Potters Gate, incorporating a speed calming raised table.
- 3. A proposal to have incorporated into the Major Road Network stage of the Farnham Infrastructure Program, the installation of a new shrouded Belisha Beacon crossing between the traffic island on the North side of Farnham Station to the opposite kerb, adjacent to the bus shelter, incorporating a speed calming raised table (subject to any complete re-design of the area).
- 4. Old Park Lane. A new pedestrian crossing at the informal crossing point between Old Park Lane and the Farnham Castle side of the A287 which is dangerous. This was raised as part of the initial FIP consultation.

A meeting also took place in March 2023 with Surrey Highways, the local SCC member, a FTC Officer and The Old Park Lane Residents' Association, which resulted in no measures being offered. One year and many near misses later, with fast vehicles continuing to come around the blind bend from the North, we are once again asking for the provision of speed calming and an electronic warning sign.

C90/23 Apologies

Apologies were received from Cllr Tim Woodhouse.

C91/23 **Disclosures of Interest**

Cllr Beaman reported a disclosable pecuniary interest as a Trustee of Creative Response. Cllr Fairclough disclosed an interest as Deputy Leader, and Cllr Merryweather disclosed an interest as Finance Portfolio holder, at Waverley Borough Council.

C92/23 Minutes

The Minutes of the meeting held on 14 December 2023 were agreed as a correct record.

C93/23 Questions and Statements by the Public

Zofia Lovell, Chair of the South Farnham Residents Association expressed her thanks to Council for pursuing the possibility of a Statutory Review of the Waverley Lane Planning appeal decision and saw it as very positive that it had not been dismissed out of hand.

With reference to item 16 on the Council's agenda - the update on Waverley Lane it was understood there are three items for the hearing and from a residents' point of view 'The Merits of the Case' was the most relevant.

During the Appeal for Waverley Lane and at other Appeals residents have raised the question about "how much "weight" (in planning terms) would be given to the Neighbourhood Plan.

It was not a question about whether it was five years old or not it was about the Community view of where housing was wanted, how the environment is protected and the willingness of the community to support it. To Residents it is about the principle on which it stands. Failure to look at the detail beyond the "timescale" is the greatest flaw.

Zofia Lovell said residents were well aware that housing was very much top of the agenda for all political parties and the pressure would be high for budgets, land supply and delivery. She also said that if residents were to commit to a Review of the Farnham Neighbourhood Plan they need the assurance that it was worthwhile.

She said that when going to law residents understood that finance and budgeting would undoubtedly be debated and urged Farnham Town Council to carry the case forward within the budget where possible. She thanked councillors for the support on the principle of the challenge.

C94/23 Town Mayor's Announcements

The Mayor advised that the first month of the year was always a quieter one as organisations planned for the year ahead.

He was looking forward to unveiling a new Town Council banner at the Farnham Town Football Club and also celebrating Chinese New Year with the Orpington Chinese Language School's Farnham Branch.

He wished Reel every success with their new venture as they opened their multiscreen cinema in Brightwells Yard.

In February there would be another first with the arrival of Fiona Byrne as Farnham's first World Craft Town Artist in Residence funded by the Farnham South Street Trust. The Mayor would be hosting a welcome reception for her, to which all councillors would be invited, along with the World Craft Town Partners.

Finally. on behalf of Council the Mayor thanked Revd Dr Michael Hopkins for his service to the Town and wished him well as he leaves the Spire Church for a wider role as moderator of the United Reformed Church's Wessex Synod.

C95/23 Questions by Members

There were no Questions by Members submitted.

C96/23 Working Group Notes

I Community Working Group

- a) Cllr Mirylees introduced the Notes of the Community Working Group at Appendix B to the agenda. Council noted the events that had taken place and welcomed the new events being planned including an extended Music in the Meadow focussing on folk/traditional music and a World Music event. Council noted that initial discussions had taken place with Reel Cinema over the possibility of hosting a gaming convention or competition in partnership with Farnham Town Council and UCA.
- b) Cllr Mirylees explained that the Gin and Fizz Festival would not be progressed in 2024 because of clashes with other similar events but this would allow for development of other initiatives.
- c) The Working Group had discussed the need for an improved visual presence and marketing for World Craft Town including a sculpture on Coxbridge roundabout. There was also an idea for a festival of light with lanterns being created by the community, and this concept was being considered for implementation.
- d) Council noted the latest position for the Farnham Business Improvement District following the successful ballot in October. A Bid Manager was being recruited, the new company limited by guarantee being created and a more detailed business plan being prepared. FTC had agreed to provide a loan for expenditure until the first levy was received, subject to confirmed agreement for repayment.

On a recommendation from Cllr Hesse, seconded by Cllr Dickson, it was RESOLVED *unanimously* that Cllr Murray be the FTC observer on the Farnham BID.

e) Cllr Mirylees reported on discussions on Community Grants for 2024-25. There had been a series of discussions with organisations that receive a contribution to general running costs or projects and work to a light touch Service Level Agreement (SLA). Community grants of less than £2,000 for one-off projects also considered.

It was RESOLVED unanimously that the following grants be approved.

2 Strategy & Resources Working Group/

In introducing the Notes of the Strategy & Resources Working Group, attached at Appendix C to the Council agenda, Cllr White advised that the Precept report and the Risk Management reports would be considered separately.

- a) **Quarterly Finance.** Council considered the quarterly finance review conducted robustly by the Working Group noting income was at 105% whilst expenditure was running at 74%. The review included the
 - Bank Reconciliation
 - Income and Expenditure Report by account code and Committee
 - Statement of Investments
 - Reserves
 - Outstanding aged debtors

The Working Group also reviewed the proposed fees and charges (at Annex I) and agreed the commissioned charged for the use of the SumUp machine would be absorbed within banking charges.

The 2024/25 Investment Strategy (at Annex 2) was agreed for recommendation to Council.

The dates for the closing of the 2023-24 accounts were agreed with papers going to the April Strategy & Resources and Council and the dates for public inspection agreed for recommendation to Council.

It was RESOLVED unanimously:

- I) The 2024-25 Fees and Charges (at Annex I) be adopted.
- 2) The Investment Strategy and 2024/25 Investment Plan (at Annex 2) be adopted.
- 3) The Dates for Public Inspection of the accounts in 2024 take place between Monday 3rd June and Friday 12th July.
- b) **Internal Auditor's report.** All councillors had received the Internal Auditor's Interim report and the Officers' comments on it. The first visit had covered the following:
 - Review of opening balances and reporting of 22-23 audit opinion
 - Follow up previous recommendations
 - Testing of expenditure first 6 months of financial year
 - Testing of income first 6 months of financial year
 - · Risk management and insurance
 - Budget monitoring reports
 - Arrangements for inspection of accounts
 - Bank reconciliations.

The Internal Auditor had advised that the Council continues to operate a satisfactory system of financial control and had a few recommendations for consideration by Council. The Officers' recommendations at Annex 3 were recommended for adoption. It was agreed to increase the level of Fidelity insurance; to improve ease of access to the transparency data on the website through the website revie, and to review the potential use of electronic order pads.

It was RESOLVED *unanimously* to accept the Officers' recommendations on the Internal Auditor's first report.

c) Financial Ombudsman's Decision. Council noted the Financial Ombudsman's report on a complaint submitted in April 2022 by Farnham Town Council into the refusal by HSBC to increase the Commercial Card limit as approved by Council, without a traceable personal financial check on one of the Council's individual signatories despite their personal finances not being connected with the Council's finances. The decision in the Ombudsman's case (PNX-4672897-PON2) is that they have no jurisdiction in legislation to look into the complaint by Farnham Town Council. This clarification and decision has implications for all town and parish councils in the country and requires a change in the legislation or there will be no recourse for poor service or problems encountered by town and parish councils with financial institutions.

It was RESOLVED *unanimously* that Farnham Town Council raises the issue with the National Association of Local Councils and the local MP of the need to update the legislation to resolve the fact that town and parish councils have no access to the Financial Ombudsman to resolve financial disputes.

d) Farnham Infrastructure Programme. Cllr Beaman reported that the Council's comments from the last Council on the town centre design had been submitted but FTC was yet to receive a response. There had been further discussions about the potential problems of the proposed in-line bustop. Cllr Hesse hoped that Cllr Beaman would use every effort to get the railings removed around town now the 20MPH zone had been implemented as everywhere was looking untidy.

Council noted that Cllr Oliver had expressed at desire at the Last FIP Board that work should commence in the summer of 2024 and that road space had been booked by Surrey.

e) Contracts and assets. Cllr White advised that the Working Group had reviewed the Assets Task Group's consideration at a special meeting held on I Ith January to which all councillors had been invited to bring councillors up to speed on plans for improvements in Gostrey Meadow. Cllr Fairclough, chair of the Task Group, advised that representatives of the Ridgeway School and their architects outlined their vision for the Café and playground and what they wanted for their pupils. The Task Group focussed on what it felt was needed ie a new playground and new toilets and did not feel it could deliver what the Ridgeway school wanted. The Working Group was quite clear it wanted to support the Ridgeway School and Cllr Murray was looking at options to help with other organisations in town such as the Spire Church and Jubilee café.

Cllr Hesse had proposed that street traders could be invited to Gostrey Meadow instead to trade on a hard standing and Cllr White suggested that a large canopy could be erected to provide cover for picnics and enjoy cover from the elements. Councillors felt this was a less risky solution for the Council.

lain McCready confirmed he had discussed the outcome with the school and they were disappointed but welcomed the offer of support from Cllr Murray. They would consider the suggestion of a mobile unit that could be used in Gostrey Meadow and elsewhere.

Council supported the proposal from the Working Group to commission a new design.

It was RESOLVED unanimously that:

- I) Plan A Architects be engaged to provide a series of drawings including a new toilet block, a new play area, an area for increased covered and uncovered storage for event equipment; a hard standing area suitable for concession use, and a covered area /canopy area;
- 2) FTC support Ridgeway School in achieving their aim of providing work opportunities for their students
- f) Younger People Task Group. Cllr White reported on the presentation by the Town Clerk and Youth Services Manager at Godalming Town Council. Hearing their experience and recommendations was very helpful. It was important to make indicative or provisional allocations of funding. Council noted the desire to make an immediate impact with the funding agreed in the budget and that the additional provision and outreach in central Farnham was recommended to be earmarked for 40 Degrees; in north Farnham earmarked for the Hale Community Centre and some additional resource covering Wrecclesham and other parts of Farnham. Part of the focus would be to effectively reduce levels of anti social behaviour in the town recognising the significant reductions in financial support from SCC for youth facilities. Cllr Beaman had suggested Council would have to consider how far FTC was drawn into a situation that might require ever greater financial support and officer time to pick up responsibilities for which FTC had no statutory requirement to provide.

Council noted initial discussions had taken place with representatives of the Hale Community Centre, 40 Degreez and the pastor of Jubilee Church. A further report would go to the next cycle of meetings. The Working Group was concerned about the challenges facing 40 Degreez and considered how best to support them and agreed that Cllr Murray and the Mayor would have a further discussion with them.

It was RESOLVED unanimously that provisional allocations be:

- I) £30,000 for additional town centre outreach earmarked for 40 Degreez as proposed in the SLA discussion;
- 2) £30,000 for activities/outreach in Hale and Wrecclesham (allocations to be determined).
- 3) £20, 000 for research in 2024-25 on priorities, need and potential funding requirements by FTC for 2025 and beyond to continue to develop a future-proof strategy for youth organisations within the FTC area;
- 4) £10,000 for additional programmed activities by partners to provide sustained activity for younger people over the longer holiday periods.

Infrastructure Planning Group. An update on the Statutory Challenge on the Waverley Lane planning application was received by Council with details of Mr Justice Julian Knowles decision to hold a rolled up hearing attached at Appendix P. The 'rolled up hearing 'would have three elements. The first on whether the extension of time request submitted by FTC's solicitor should be allowed. The second on whether the Aarhus Cost Capping Convention applied in this case and the third on the substantive merits of the request for leave to appeal. Council would discuss the detailed elements in exempt.

Council also noted the latest position with the Farnham Neighbourhood Plan and the Waverley Local Plan with a call for sites currently underway. There would need to be further discussion on what was considered a 'strategic site'.

C97/23 Precept 2023-24

Cllr White introduced the precept report at Appendix D advising that the Strategy & Resources Working Group was mindful of the financial pressures on the local community but also of the need to invest in the future of the community particularly for opportunities for younger people and the challenges of climate change.

Cllr White said that whilst there was no capping on Town and Parish Councils, increasingly they were expected to take on services being stopped by principal authorities. Paragraph 6 in the report was helpful, showing the exemplary stewardship by Farnham Town Council. In 2013 it was spending £5.60 above the average of town and parish councils but in the current year it was £6.14 below the average. The Town and Parish element of Council Tax represented 3% of the total.

After careful consideration, the Working Group was recommending a £4.93 increase in the band D level for the year ahead, representing just 9p per week. This would result in a total precept of £78.15 or £1.50 per week per Band D property, still placing FTC below the national average whilst fulfilling the commitment to invest £90k in supporting younger people.

Council noted that further consideration was given as to whether income targets could be further increased and that other inflationary pressures were being absorbed within the budget. The Working Group had proposed using some reserves to minimise the level of increase.

It was RESOLVED unanimously that:

1) Reserves of £22,382 be used to reduce the 2024/25 precept increase;

2) The 2024/25 precept be set at £1,424,818 representing a Band D equivalent amount of £78.15 per annum or £1.50 per week.

C98/23 Risk Management Report

Cllr White Introduced the Risk Management report at Appendix E. Council noted that each of the Working Groups had reviewed the risks affecting their areas and were supported by an independent risk review by Worknest, financial risks review by the independent Internal Auditor as well as by Council policies and procedures.

It was RESOLVED unanimously that:

- 1) The Risk Management report be welcomed and adopted;
- 2) The work done by the Working Groups in managing risk be noted.

C99/23 Planning and Licensing Applications

Cllr Laughton introduced the notes of the Planning & Licensing Consultative Group meetings held on 8th and 22nd January attached at Appendices F and G to the agenda.

Some of the highlights included an application for a 65 bed care home next to Bishops' Meadow where the Town Council supported concerns raised by the Bishops meadow Trust, and a 26 dwelling application in Wrecclesham Hill which was contrary to the Farnham Neighbourhood Plan. An application in Vicarage Hill should have a detailed Transport Management Plan as it is a restrictive site and comments had been made to an application in Gong Hill Drive for outbuildings needing to be in line with the building line and not too close to the road.

In terms of licensing there was concern over an application to extend hours to 2.30am which would have a detrimental effect on neighbours.

C100/23 Actions taken under the Scheme of Delegation

There were no additional actions to report.

C101/23 Reports from Other Councils

There were no reports from other councils.

C102/23 Reports from Outside Bodies

Cllr Dickson reported that the Revd Alan and Revd Lesley Crawley were leaving Badshot Lea and Hale with a final service on 4th February. Council noted the contribution they had made to the communities in North Farnham in which their churches were located.

C103/23 Date of Next Meeting

The date of the next meeting was agreed as 14th March at 6pm.

C104/23 Exclusion of the Press and Public

On a proposal from the Mayor, it was RESOLVED unanimously that the press and public be excluded for discussion of two exempt items from the Strategy & Resources Working Group.

C105/23 Any confidential matters (if required) arising from discussions of the Working Group notes.

Exempt items arising from the Strategy & Resources Working Group.

1) **Younger People Support.** Consideration of contractual matters for the allocation of funds for developing activities for Younger people.

Council reviewed the allocations in terms of agreements that needed to be put in place to ensure the outcomes desired could be delivered by the organisations that would be receiving the funds. These included future use of building and Service Level Agreements in the initial year of support.

Council noted that some of the support was to help younger people who were facing challenging circumstances and should be supported by Surrey County Council, particularly given the rise of mental health issues since covid.

Cllr Fairclough and Cllr Merryweather left at this point.

2) Statutory Challenge for Waverley Lane. Council discussed the approach to the hearing for the legal challenge and the three elements that were to be considered in the rolled-up hearing. The support of the local community was welcomed, and it was important to fight for the Neighbourhood Plan as the decision on the Waverley Lane application was a travesty.

I. Apologies for absence

Apologies were received from Cllr Jackman and Woodhouse.

2. To receive any declarations of interest

None received.

3. Notes of the previous meeting

The notes of the previous meeting were agreed.

4. Climate Change

Councillors and Officers received an informative and inspirational presentation from Alister Young about the work the volunteer Water Rangers and The River Wey Trust undertake in testing the condition of the rivers in and around Farnham. The presentation delivered at the Working Group was forwarded to all members of Council. It was suggested that FTC may have

a historic Septic tank at the depot. Officers will look to confirm the location and investigate the condition to rule out any potential impact on the local water supply.

The Group were informed by Officers of some of the initiatives for mitigating Climate Change this year with Officers looking at water catchment from Council owned buildings to help with watering of the seasonal displays at the Town Hall and also water catchment throughout the Town Centre if permission is allowed from businesses and residents.

The Group recommended that:

- Officers seek to purchase water butts and irrigation systems to help with the watering of the seasonal floral displays and encourage businesses and residents to adopt the same;
- 2) Water testing kits be purchased for schools (3sets) and individual volunteers (6 sets) at a cost of £1,500 from the 2023-24 Community Initiatives budget.

5. Biodiversity Legislation

The Working Group discussed the training delivered by Surrey CC (slides to be circulated to all councillors) and felt that Farnham Town Council were undertaking the activities and measures talked about already and that Officers should continue to progress and increase Biodiversity projects and initiatives were ever possible.

6. Allotments

The Working Group were given an update on the available plots with the allotments which were currently at 20 and noted the work Officers are undertaking to fill the vacancies with some prospective allotment people taking a while to respond back. It was hoped due to the amount of people on the waiting list being at approximately 100 this would not take to long.

Councillor Brown updated the Working Group on the recent allotment liaison meeting stating that it went well and that all the representatives from the allotments were present.

All the allotment representatives were informed that there would be a rent increase in the next year with another £5 per single plot. The group was informed that this was due to increased costs and that the allotment service has to be self-sustaining.

The group briefly discussed allotment insurance and that it was good that it was mandatory (at £2 per tenant).

It was agreed that the allotment show would be held in September and that some members of the group would be attending the Farnham in Bloom Community Day on the 23rd March showcasing all of Farnham's allotments.

It was also agreed that the allotment lecture would be held in May and the topics covered would be helping to improve Biodiversity and the use of alternatives to chemicals within the allotments.

Councillors and Officers spoke about the land between the Six Bells Allotment site and the Hale Road. The land isn't registered and allotment tenants have asked Councillors if FTC can register the land so improvements can be made to the area currently used for parking by allotment holders. The Working group noted this had been agreed at the January Council meeting and was being progressed.

7. Parks and Open Spaces

Councillors were given an update on the current works program and were informed that the following works had been completed.

Gostrey Meadow

- The area to the rear of the Bowling Green had been cleared of old structures.
- The chain link fence had been removed and the area was now open to park users.
- The Rose beds adjacent to the South Street entrance had been cleared with any decent roses re located and the area to be planted with perennial plants which will thrive better.
- The large Lombardy Poplar had been removed from Gostrey Meadow.

Riverside

- The Willows along the Riverside path were to be pollarded in March as part of the annual tree program of works
- Councillors were informed that Wey Valley House had expressed a wish to extend their garden into an area of grass belonging to FTC along the Riverside. Councillors were favourable to this as long as the boundary was continuous without a gate. Councillors asked Officers to measure an appropriate amount of the grass area prior to responding to Wey Valley's request.

The Working Group have recommended to Strategy & Resources that Officers contact Wey Valley House to ascertain the suitable size of grass area to be leased, as long as it doesn't affect future Farnham Town Council plans and has no access onto the rest of the Riverside Green Space, to enable them to extend their green space/garden due to a redevelopment project.

UCA, Battings and Haren Garden

Councillors noted the recent work of tree planting and another large Lombardy Poplar removed from Haren Garden

Green Flag

Councillors were informed that all the Green Flag portfolios had been submitted with Hale Cemetery being entered for the first time and that judging for this Cemetery will be in May or June. Other sites will be mystery judged at some point throughout the year.

8. Street Furniture

Officers gave the Working Group an update on the following items:

Graffiti

Officers informed the group that graffiti has recently escalated throughout the town centre with lots of tags and markings placed on street furniture. The Group were also informed that Aquarius who undertake the graffiti removal for Farnham Town Council conducted another run in the last month to clean up the town. The Working Group were also informed that there is a lot of Graffiti around the new Brightwell's development and Councillor's asked Officers to report this to Waverley Borough Council. Cllr Murray spoke regarding a large piece of Graffiti near to the Bourne stream and that he has spoken with the resident who owns the wall and they have agreed to fund the purchase of anti graffiti paint to cover the wall which Farnham TC will purchase on their behalf and a community group will undertake the painting with some assistance from Farnham Town Council Outside Workforce which would clear a path to the wall.

2. Benches / Bins in open spaces

The Working Group were notified that the three remaining Coronation benches would be installed by the end of March with them being placed in Hallifax Gardens in Rowledge, Hale Cemetery and along Riverside.

3. Notable names of Farnham Wall.

Officers gave an update on the progress of 4 of the names agreed at full Council to go onto the wall. They are as follows:

- Brigadier Paddy Blagden CBE 26th June as part of Armed Forces week. (provisional)
- Author Edgar Austin Mittelholzer 6th May 2025 being 60yrs of death. (provisional)
- Founders of the Rural Life Living Museum Madge and Henry Jackson MBE possible date of the 24th April 2024 when it will be the 40th Anniversary of the set up of the museum Charitable Trust.
- Distinguished illustrator (including Lord of the Rings and Narnia), Pauline Baynes possible date of the 20th October 2024 being the 75th anniversary of the first illustrated Tolkien book "Farmer Giles of Ham" by Pauline Baynes was released.
- A further name of a Rowledge resident recommended to be included was Alan Mitchell, (1922-1995), an Internationally acclaimed Tree expert and Dendrologist. He was recommended for inclusion in 2025, the 30th anniversary of his death.

Recommendation to Council

Alan Mitchell, (1922-1995) Internationally acclaimed Tree expert and Dendrologist be included on the Notable Names of Farnham wall.

9. Farnham in Bloom

Officers updated members regarding the appointment of Pat Evans as chair of the Farnham in Bloom Community Group. The next meeting of this group ws on the 6th March where the group would be asked for input on schools competitions and Secret Garden categories.

Members noted the list of events for 2024. Officers outlined the plans for the Farnham in Bloom Community Day on Saturday 23rd March. The take up from community groups was good with a children's animal farm booked, volunteering opportunities and live music.

Farnham in Bloom are entering 5 categories this year for South and South East In Bloom and had also been nominated to take part in RHS Britain in Bloom final in the Town Centre category.

Sponsorship confirmed to date includes The Patio Black Spot Removal Company Ltd (Gold), BBS Ltd (Gold), Zenzero (Silver) and Bush Hotel (Silver).

10. Cemeteries and Burial Matters

Officers gave an update on the current burial figures. The figures were very similar to those of last year. The income is slightly down against budget but Officers informed the Councillors that there were two funerals booked for March so the figures should improve. Councillors noted that the expenditure was also down.

Officers gave an update on the current grounds maintenance works within the cemetery and Councillors noted that the main hedge in West Street would be cut in March before the nesting bird season.

Councillors were also updated on the recruitment for the replacement of Adrienne Owen and that it had been re advertised with interviews before the end of March.

11. Finance

Councillors noted the current financial position.

12. Date of the next scheduled meeting

The date of the next meeting was agreed to be held on the 5th June 2024 at 4:30pm.

1. Apologies

Apologies were received from Cllr Hesse and Cllr Martin.

2. Declarations of interest

The Town Clerk declared an interest as a former director and saver with Boom Credit Union.

3. Minutes

The Notes of the meeting held on 16th January were agreed.

4. Finance Report

i) The Working Group received the latest financial position and reviewed the Income and Expenditure report to 28th February 2023 at Appendix Bi and Bii; and the Outstanding debtors and write-off of a £75 invoice for a company that had closed at Appendix C. The Working Group accepted there would also need to be a small write-off of allotment income

- for October 2022-September 2023 where there had been unfilled vacancies. The Working Group noted that with income running at just under 110% and expenditure (with commitments) running at some 93% there would be an expected surplus at the end of year. It was noted that not all commitments may be implemented in the current year.
- The Working Group received a proposal from Boom Community Bank at Appendix D to support the roll out of a no interest or low interest loan scheme to help those facing hardship and avoid the need for people to take out loans at exorbitant rate of interest. The Working Group noted that Boom started as the ethical not-for-profit SurreySave Credit Union and had now expanded its area through mergers to cover Sussex and Berkshire. One of the benefits of the Boom Community Bank was its financial literacy education programme and its requirement for borrowers to become savers to help create financial resilience. It was noted that in Farnham there were currently 32 people with loans (totalling £56k). After discussing a range of options, the Working Group agreed that supporting a No Interest Loan Scheme for Farnham residents would help with the ongoing financial crisis and supplement the work done by the Farnham Support Fund with its hardship grants and fuel poverty payments. It was agreed to recommend a contribution (effectively a grant of £15k subject to an agreement on the scheme's operation locally) for a pilot scheme. It was also agreed to recommend that Farnham Town Council opened a savings account with Boom Community Bank with an initial deposit of £15k noting that the dividend payable (proposed 0.35% for 2023/2024) would be similar to the current interest rate on the HSBC call account. It was noted that the Boom Community Bank AGM would be taking place in April and representatives would be invited to attend.

Recommendation to Council.

It is recommended that Farnham Town Council

- 1) Opens a savings account with Boom Community Bank with an initial deposit of £15,000;
- 2) Supports the creation of a No-Interest Loan Scheme (NILS) for Farnham with a contribution of £15,000 for the pilot; and
- 3) Authorises the Town Clerk to finalise the parameters of the NILS project in Farnham with Boom Community Bank.
- iii) Grant requests update. The Working Group recommended supporting the proposal from the Environment Working Group for a grant to buy water testing kits for the Water Rangers with a grant of £1,500 from the 2023-24 Community Initiatives Fund.
- iv) Review of banking arrangements. The Town Clerk advised that initial discussions had been held with a local bank to see if there were advantages in moving the FTC account from HSBC. A further report would be presented.

5. Contracts & Assets update

- I lain McCready resented the report on Contract and assets at Appendix E. This included:
- i) Progress on upgrading the telephone system from ISDN when it is switched off from VOIP. Two quotations received to date with others expected as part of the IT support review.
- ii) The latest position on fixing the CNG compressor at the depot. It appears that a motherboard at a cost of £1,200 may be required following discussions with the Italian manufacturer. This may have been due to a faulty installation. The cost of diagnostic tests are being investigated.
- iii) The completion of the installation of the new polytunnel with the fencing still to be done, hopefully in 2023/24.
- iv) The upgrade of First aid kit and equipment required for events and depot (funded out of current budgets).

- v) The refurbishment of the depot, with clearing and reorganisation of the outside areas and the re-equipping of the outside workforce break room and kitchenette.
- vi) The Gostrey gates refurbishment tenders had been completed with work allocated to Aegyssus at a cost of £3.075 and Lee Humphries at a cost of £6140 for the pillar rebuilding and internal tarmac works. The dropped kerb roadway improvements would need to await approval from SCC.
- vii) The search for the replacement Goupil electric vehicle was continuing.
- viii) The 2023/24 pathway repairs, normally in the cemeteries were proposed for Battings Garden and Gostrey Meadow near the bridge/bowling green. Two quotations had been received so far at a significantly higher rate than usual with a third awaited. It was agreed to recommend that the works in progress subject to a maximum cost of £16,950 for the Gostrey meadow and that the tender be let to the most economically advantageous tender.
- ix) The Working Group considered the further discussions with SurreyCC and Farnham Hoppa Connects service for an electric charging point at the Council offices (all costs funded by Surrey) to charge two vehicles overnight and one during the day. It was agreed to recommend the installation of charging points suitable for charging the Hoppa vehicles overnight be agreed subject to a contract and costs payable by Surrey CC.
- x) The Working Group noted the Wrecclesham Gateways project (funded by Section 106) was in hand and that the repositioning of the Longbridge CCTV was also taking place.
- xi) Cllr White advised there was an area by Jubilee Walk that had flooded. Iain McCready advised he would be taking remedial action along with maintaining and planting of some new reeds in the adjacent overflow pipe.
- 2 Notification of Zurich Insurance renewal increase. The Working Group noted that as a result an internal review and the fact that Zurich had paid two historic claims in one year, the Council's long term agreement was being re-negotiated and may rise to around £20,000. Officers were in discussion on ways to minimise the impact.
- The Working Group received details of the Wrecclesham Community Centre Rent Review at Appendix F. An initial meeting with Trustees had taken place and a further one planned.
- The Working Group considered a request for the lease of a piece of land at Farnham Riverside by the Abbeyfield Wey Valley Society at Appendix G to its agenda. Officers visited Wey Valley House regarding the proposed extension of its garden following some redevelopment works. Officers advised that the piece of land to the North East (Area A) would not interfere with plans for the area (subject to a final measuring of the extended request and there being no access from the FTC land) but the land requested adjacent to the river (Areas B and C) may cause problems for the Walk and Stride widening which had been agreed for the Brightwells Yard Scheme. Officers also advised that some temporary repairs to the path were being implemented pending the park and stride work on the footpath widening.

Recommendation

It was agreed to recommend to Council that:

- I) Officers pursue a lease for a rectangular piece of land to the North East to be coterminous with the Abbeyfield lease from Waverley for Wey Valley House (believed to be 85 years);
- 2) The additional land request be not supported.
- 5 Registering of unadopted land.

The Working Group discussed the general issue of registering unadopted land that had an amenity value for the local community. This had arisen as a result of the improvements

required to the access to the allotments at Six Bells, and the plans by Abbeyfield Wey Valley to register a piece of land by Farham Riverside which was being cleared by them to create a car park. There was concern that the development of the latter piece of land would impact on a biodiverse green corridor. The Contracts and Facilities Manager advised FTC had taken on the land along Farnham Riverside to improve it as an attractive green space and improve the biodiversity. It had initially been considered that it might also include the piece of land in question, with a historic footpath over it, but ownerships in this area were complex. Councillors wondered if a compromise might be available for a smaller footprint to be made available with the land retained for biodiversity. Others thought that a car park was unnecessary as the Care home was next to a large public car park and land that had a public amenity value should, in principle, not be acquired by a private organisation.

Recommendation:

- I) Farnham Town Council reviews unregistered public amenity land that has community or environmental benefits and registers appropriate sites to be retained in public ownership.
- 2) FTC objects to the loss of the green corridor next to Farnham Riverside and seeks to register the land for public ownership.

Cllr Murray and Cllr Fairclough left at this point.

6. Farnham Infrastructure Programme

Cllr Beaman provided an update on the FIP advising that following consultation the intention was to move the bus stop shelter from East Street to Dogflud Way and have a bus stop pole with real time information in East Street. The issue with the inline bus stop in the Borough was continuing and further representations had been made by Cllr Powell identifying congestion that would occur using existing CCTV information.

SCC had now issued the proposed design for Castle Street which showed them removing the historic ironstones and using them as a feature around street furniture and trees. This was considered to be worrying and would be looked at by the Infrastructure Planning Group ahead of the April Council. It was noted that Surrey was still meeting groups individually (ie WBC and FTC) despite requests by both for joint meetings. As FTC and WBC officers were discussing the proposals it is known that the concerns are shared.

The scheme materials were due to be installed at the back of the Town Hall shortly and would be available for Council to consider them.

The Woking Group noted the next FIP Board meeting would take place on 22nd March.

Cllr Brown left at this point.

7. Reports of Task Groups

I Neighbourhood Plan

Jenny de Quervain gave an update on actions that were progressing on the Farnham Neighbourhood Plan. The funding from Locality was being used to provide mapping layers for the Urban Capacity Review and other elements, and the planning advisor had been commissioned to progress a number of tasks until the end of March.

Andrew Longley had updated town and parish councils of the next steps with the Local Plan, working towards an adoption in 2027. At this stage the Neighbourhood Plan would need to be in general conformity with the new Local Plan, or a further update would then

be required. WBC was holding a Town and parish Councils Planning Forum on 12th March where the Local Plan work programme would be explained further.

One of the issues for consideration was the number of homes to be designated for the allocation of strategic sites to 2043. The number in the Neighbourhood Plan is currently 100 but there was a proposal to reduce this. The Working Group felt that in Farnham, there was no need, at this stage, to reduce this number below 100 particularly as the number of houses being built in Farnham was progressing on schedule. The call for sites was continuing until 31st March.

Waverley was using the CommonPlace engagement platform as a means of seeking input to work on the new local plan and other planning policy documents https://planningwaverley.commonplace.is/.

One important element being reviewed was the Infrastructure Development Plan and the Farnham IPG would be seeking ward members' views at what infrastructure requirements should be put forward.

The Town Clerk advised that there had recently been a discussion with agents acting for the owners of Dyas Yard to see if there were further opportunities for improvements to this area. A further update will be provided in due course.

2 Waverley Lane Statutory Challenge

The Working group noted that the Statutory Challenge had now been scheduled for 1.5 days on the 16^{th} and 17^{th} July.

3 Younger People Task Group

The Notes of the Younger People Task Group were attached at appendix H. The meeting of the wider members had included a presentation by the PC Barnes, Surrey Police Youth Engagement Officer who works with local authorities and schools to help keep vulnerable young people safe and support young people at risk of displaying or being victim to antisocial behaviour. PC Barnes advised of the importance or reporting anti-social behaviour and said that in Farnham in 2023 there were 6 public order offences and 2 knife offences reported.

The Task Group heard that Surrey had 'recommissioned' its youth service with all age groups under one umbrella and a loss of some £800,000 for young people services across Surrey.

The Younger People directory on the FTC website was being developed, to be populated with information by each organisation providing services in March.

The Working Group had a useful discussion on the allocations agreed for the new FTC funding and a consideration of the logistics of outreach in the town centre, Hale and Wrecclesham to determine which organisation was best for the outreach in Wrecclesham. Further discussions with various organisations were planned and a service level agreement for the additional funding would be agreed.

In discussion, the Strategy & Resources Working Group clarified that in the first year, the £30k allocation for Hale and Wrecclesham should be split equally as far as possible although one option for consideration was whether the Hale Community Centre team or others would support this work. The Working Group also discussed whether the funding for Wrecclesham might support general provision for younger people in that area rather than specific outreach and this would be part of the conversation with partner organisation.

Cllr White had drafted a paper to help explain the Farnham approach to supporting younger people setting out the different funding elements for external partners and as a basis for funding applications to others. It was agreed that whilst this amplified the Task Group notes it would be useful after agreements with partner organisations had been clarified.

8. Consultations

The Working Group considered two consultations received from Waverley which were issued with a short timescale for response.

I The Waverley Economic Development Strategy and Action plan (https://modgov.waverley.gov.uk/documents/s61683/WBC%20DRAFT%20Economic%20Development%20Action%20Plan%202024_26.pdf).

It was disappointing that Town and Parish Councils had not been involved in the development of the document after planned meetings with the consultant were cancelled, but the document and its approach were to be welcomed. The covering report at Appendix I to the Working group agenda set out some initial thoughts to be supplemented by Council.

The strategy proposes a 'Creative Waverley' brand to be developed which builds on and benefits Farnham with UCA and World Craft Town designation.

There is a proposal for 'Maker spaces' centred around Farnham, with a focus on activating underutilised public assets and retail units to create a new network of workshops and makerspaces that encourage creative entrepreneurialism and attract inward investment' This has previously been proposed by FTC and fits with FTC agreed priorities.

The document repeatedly mentions collaborating with UCA which is positive. It mentions a review of Council owned assets to be used to 'provide low cost business space' which should be support as it will strengthen the World Craft Town programme and incubator spaces for UCA graduates. The 'low-cost' part is important as traditional makers cannot afford to rent space in Farnham.

Alongside more traditional craft maker spaces, the strategy identifies the need to tap into the digital world by creating a new 'video Games incubator Centre'. This fits with the move to digital and media that UCA have made. Waverley will need to understand the reasons why the digital gaming centre in Aldershot at the old Town Hall in Grosvenor Road did not go ahead.

In terms of gaps, there doesn't seem to be much on events and visitor economy. WBC has a fantastic asset in Farnham Park that could and should be used for larger for Events/Festivals.

There are opportunities to use SCC assets such as Brightwells Yard and the Library as economic drivers with, potentially, a creative hub – including incubator space alongside maker spaces, café and an expanded 'National craft Museum' (with the craft study centre involved).

There is an opportunity lost in the document as much of the resource indicated seems to be 'officer time'. There is concern with staffing reductions and other pressures that this may limit the potential achievements in the action plan.

Recommendation

Subject to any additional comments at Council, the above comments form the basis of FTC's comments.

2 Waverley anti-social behaviour policy and Public Space Protection Order.

Waverley Borough Council is currently reviewing the Public Spaces Protection Order (PSPO) that covers Godalming, Farncombe and Waverley managed parks and greenspaces and has given two weeks for comment from 27th February until 13th March. Disappointingly, this timescale is well outside the expected consultation periods which should be a minimum of six weeks. Further details on the current PSPO and background to the order at Waverley Borough Council - Anti-social behaviour PSPO.

The PSPO was introduced in April 2021 and is due to expire on 20 April 2024. It was put in place to address various concerns regarding:

- Alcohol, drugs, and group anti-social behaviour in Godalming and Farncombe
- The lighting of barbecues and bonfires in Waverley managed parks and greenspaces across the borough.

The PSPO aims to ensure that public spaces can be enjoyed free from anti-social behaviour. It is not about stopping the responsible use of public spaces, but they do provide councils and the police with powers and tools to tackle unreasonable and persistent behaviour and issues that are adversely affecting communities.

The proposed order includes all WBC land most of which never experiences any issues but excludes many areas in Farnham that have had significant issues such as Gostrey Meadow, Victoria Garden, Green Lane Cemetery and Farnham Riverside. There have been other incidences in recent years of drug dealing taking place in West Street Cemetery, outside Badshot Lea Cemetery, so it is proposed that all FTC land is included so any issues identified can be addressed.

Recommendation to Council:

Subject to any comments or spaces identified by ward councillors, FTC responds requesting all FTC land be included in the new Public Space Protection Order.

9. Town Clerk update

The Town Clerk advised that the HR Panel was recommending a change of public opening hours of the Council Offices to the next Council. One of the drivers for this was to facilitate staff meetings and training, and because the public access requirement was reduced since Waverley closed its shared reception facility. The aim is to open the doors from 10 to 4.30 every day but there would still be a telephone response from 9 to 5 Monday to Thursday and 9 to 4.30 on Friday. When there were pre-arranged meetings to which the public were invited, the doors would still open earlier. This recommended new arrangement was endorsed by the Working Group.

10. Date of next meeting

The next meeting was agreed as being 2pm on Tuesday 16th April.

The meeting ended at 5.40 pm

- viii) The Panel noted that the Outside Workforce hours were moving back from the experimental annualised hours to standard hours throughout the year, and also received and agreed some specific details relating to individual staff contract matters including the payment of some backpay for contractual holiday pay that was outstanding and set out at Exempt Appendix F.

Farnham Town Council notes that the proposed development has been reduced from seven dwellings to six in the woodland to the rear of 42 Frensham Vale.

The repositioning of dwellings is not sufficient mitigation to prevent flooding. Farnham Town Council maintains its objections to the proposed erections of dwellings including association access and parking in this location. This application must be considered with WA/2023/02071 for the erection of a dwelling with access and associated works, together they facilitate the access for both proposed developments, also subject to amendments due to severe surface water flooding across the site.

The Agent has referenced development sites allowed at appeal as evidence in the determining of this applications. The dates of these decisions reflect the outcomes of the appeals. Farnham's Neighbourhood Plan was adopted on 3 April 2020 with sufficient housing allocations to meet Farnham housing need.

This site is not an allocation in the Farnham Neighbourhood Plan, situated outside the built-up area boundary covered by policy FNP10 Protect and Enhance the Countryside, which seeks to prevent inappropriate development and enhance the landscape value of the countryside (FNP10e)). The site is bounded by policy FNP8 South Farnham Arcadian Areas in place to a) maintain the informal rural character and wooded appearance of the area; b) retain and reinforce trees and hedged boundaries important to the character of the area; c) demonstrates that the design, layout and siting of the proposals will not have any adverse effect upon the setting. These proposals will have a negative impact on the character and setting with the removal of trees and hedging and erode the ancient woodland buffer in a densely wooded area. Loss of trees and vegetation will also result in more flooding on the site and on Frensham Vale, especially surface water flooding which has not been adequately considered. The proposed materials and design are out of character, not compliant with the Farnham Design Statement (FDS) and policy FNP1 a) design and boundary treatments; b) FDS guidance; d) does not respect the site; e) harmful rather than well integrated; f) increasing the risk of flooding on the site and access to it. Although individually designed contemporary dwellings have been referenced in this application, this proposal is for development built en masse.

Farnham Town Council notes that an amended landscape plan has been received. It appears that the gate from the site on to the Bishop's Meadow has been removed from the plan. This amendment is welcomed as it was unacceptable to have direct access on to the water meadow, a Site of Nature Conservation. The proposed 1.8m native hedging and trees will provide some necessary screening. Conditions must be included to ensure long-term maintenance of planting across the site.

Farnham Town Council raised in its previous comments the lack of drawings showing the proposed PV panels. Can drawings be requested?

Farnham Town Council maintains its previous comments including: the site has insufficient infrastructure for surface water management and no rainwater harvesting, the filtering of surface water runoff is also vital given the site's vicinity to the water meadow which drains into the River Wey; to soften the impact of the extensive white render, it is suggested that the colour be muted, this would assist with the visual impact and impact on wildlife, especially with reflected light of the outdoor lighting close to a Site of Nature Conservation.

Farnham Town Council appreciates the consideration has been given to materials used on adjacent housing and the wider area, including light-coloured rendered elevations. The expansive areas of white render on the proposed development are very stark and should be softened, an example being RAL 9002. This may also reduce reflected light into the biodiversity opportunity area of the water meadows.

Farnham Town Council welcomes Conditions in line with SCC as the Lead Local Flood Authority to ensure better provision for surface water management in this

sensitive location within the Wey and tributaries management catchment. Opportunities for rainwater harvesting and its use have been missed and management of rainwater is insufficient for the size of the site in flood zone 2, bounded by flood zone 3.

Farnham Town Council supports the objections of the Bishop's Meadow Trust to a gate for direct access on to the water meadow from the development. Access to the Bishop's Meadow and footpath 167 and others beyond is via Whitlet Close approximately 100m from the access to the development, private gates on to the water meadow are not acceptable. Additional trees should be planted on the boundary with the Bishop's Meadow to provide screening of the development from the water meadow.

The proposal notes under 'Infrastructure Requirements - Education' the need for financial contributions towards education as close to the boundary with Waverley/Farnham Parish boundary. A Section 106 Agreement with Surrey County Council for school funding would be appropriate.

Objection is raised to the wording under 'Infrastructure Requirements – Health'. Contributions are not for Rowlands Castle Surgery to provide additional capacity. This must be corrected to Holly Tree Surgery, the closest GP Practice, and include contributions to Farnham Hospital.
